The Company's operating result for the three-month period ended 30 June 2021 resulted in a net loss of Baht 18.71 million in the consolidated financial statements, the net loss decreased by Baht 3.98 million or 18% from the same period of prior year.

1. Revenue and cost of sales from property development business

In this period, the Company did not have revenue from property development business due to the "Focus Ploenchit" condominium was sold out. At present, the new projects are under construction. While in Q2/2020, the Company has revenue from property development business Baht 4.75 million from 1 unit ownership transferred at the "Focus Ploenchit" condominium and cost of sales was Baht 3.91 million.

2. Selling and distribution expenses

The Company's selling and distribution expenses was Baht 0.13 million, which decreased by Baht 0.85 million or 87% as compared to Q2/2020. The significant decrease was due to decreasing in sales and promotion expenses for support sales of project the "Focus Ploenchit" condominium.

3. Administrative expenses

The Company's administrative expenses was Baht 22.82 million, which increased by Baht 0.80 million or 4% as compared to Q2/2020, which was Baht 22.02 million. Main increase was due to staff costs increased by Baht 1.99 million. While bank charges decreased by Baht 1.44 million.

4. Finance Cost

The Company's finance cost was Baht 0.35 million, which decreased by Baht 1.06 million or 75% as compared to Q2/2020, which was Baht 1.41 million. Main decrease was due to repayment of entire loan from financial institution according to ownership transferred at the "Focus Ploenchit" condominium.

5. Income tax (expenses) income

The Company has income tax income for the period Baht 3.57 million, which increased by Baht 3.61 million or 9,254% as compared to Q2/2020, the income tax expenses was Baht 0.04 million. The increment was due to adjustments of deferred tax assets of subsidiary companies according to increasing in deficit.
